Dear Cedar Grove Water Company, Inc. Customer,

On April 22, 2025, the Arizona Corporation Commission approved a rate increase requested by Cedar Grove Water Company, Inc. ("Company"). Per Decision No. 80694 ("Decision"), the new rates will become effective for all service beginning on or after May 1, 2025.

The approved rates will increase a typical residential 5/8 x 3/4-inch meter customer with median usage of 2,334 gallons by \$19.49, from \$41.84 to \$61.33, an increase of 46.58%. The rate case expense surcharge will add an additional \$1.64 per customer per month, which will terminate within three years from the effective date of the Decision or once a total of \$30,000 has been recovered, whichever occurs first.

All items billed at Cost shall include labor, materials, parts, overheads, and all applicable taxes.
