Why are there contaminants in my drinking water?

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. At low levels, these substances are generally not harmful in our drinking water. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination.
