# CUSTOMER NOTICE CAYETANO, INC. DBA LAKEWOOD WATER COMPANY DOCKET NO. W-01809A-22-0248, ET AL.

Dear Lakewood Water Company Customer,

On April 17, 2023, the Arizona Corporation Commission ("Commission") approved a rate increase requested by Cayetano, Inc. dba Lakewood Water Company ("Company"). Per Decision No. 78912, the new rates become effective for all service provided on and after May 1, 2023.

The adopted rates will increase the typical residential bill for a 5/8-inch meter, with a median usage of 5,677 gallons, from \$18.35 to \$21.61, for an increase of \$3.26 or 17.77%. Decision No. 78912 also authorizes a rate case surcharge of \$1.65 per customer, per month, which will go into effect on May 1, 2023, and shall terminate on April 17, 2027, or once \$25,000.00 has been recovered, whichever occurs first.

Decision No. 78912 also authorizes the Company to obtain a 20-year amortizing loan from the Water Infrastructure Finance Authority of Arizona ("WIFA") to finance a new well, storage tank rehabilitation and expansion, a booster pump, communication equipment, and pipeline, in an amount not to exceed \$1,218,750 at an interest rate to be determined at the time the loan is closed. The Company anticipates the loan will close in September 2023 and the WIFA loan surcharge will take effect four months thereafter. With the estimated WIFA loan surcharge of \$32.17, the typical residential bill for a 5/8-inch meter, with a median usage of 5,677 gallons, would increase to \$53.78, a total increase from current rates of \$35.43 or 193%. The rate case expense surcharge will add an additional \$1.65 to the median 5/8-inch meter bill.
